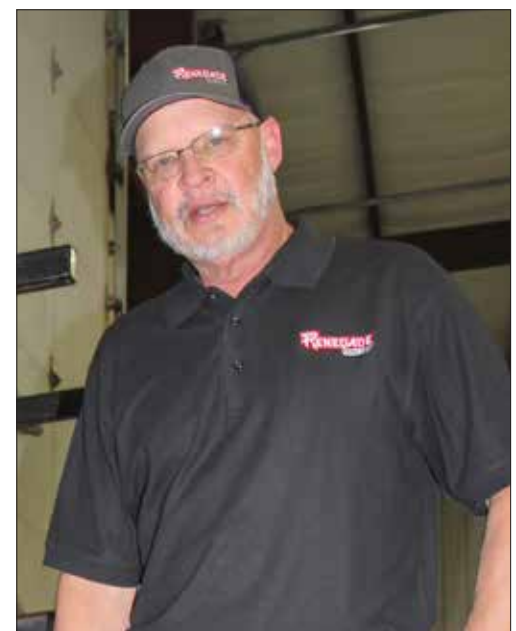
"We are incredibly grateful for Perry's leadership over the last five years," Gray said.
